Describe in your own words how you have been victimized.

On November 2nd 2011 Our agreement was signed by myself Joshua Irino of E Concert Live,LLC/Gweedo Productions and Bing Worthington of Bing & Fox Unlimited. For services of Tha Dogg Pound (Delmar Arnaud aka Daz Dillenger & Ricardo Brown aka Kurupt) Artist live performance on December 2nd 2011 in Tempe, AZ. at The Clubhouse Music Venue 1320 E Broadway Rd. and December 3rd 2011 in Tucson, AZ. at DV8 Night Club 5851 E. Speedway Blvd.

The agreed payment for the services \$3,750.00 for each performance date totaling \$7,500.00 deposit of 50% was paid on November 7th using a business check from E Concert Live, LLC. Chase Bank to Zabre Productions Chase Bank as indicated in the signed agreement.

On or around November 27th 2011 Mario Ottesen aka Guido of Gweedo Productions & Myself were contacted by Miles Saunders who claims to be brother to Ricardo Brown aka Kurupt. Miles Saunders contacted the FM radio station we contracted to advertise the events before contacting us and told them the DOGG POUND did not know about these events and were not going to show up to provide services they were contracted for. The station then gave Miles Saunders our contact information he contacted us to relay the message. Unsure of the source of this information I contacted Fox of Bing & Fox unlimited but was unable to get in touch I left voice, text and emails with no response. I then contacted Miles who put me on conference call with Big U & Hump who also claim to be family of Ricardo Brown they said Dogg Pound is overseas and would not be able to make it in time for these events and they did not receive the deposit. Unable to verify this information with Bing and Fox Unlimited I called Fox conference with myself, Miles, Big u & Hump we left a voicemail. After hanging up the line with Fox I demanded from Miles, Big U & Hump to speak with Bing Worthington who signed the contract. Miles contacted me later that day and said Bing was on a flight overseas with Tha Dogg Pound and could not be reached.

On November 28th I got a text from Fox that read I will give you back your deposit of \$3750.00 plus \$3250.00 for losses totaling \$7000.00 (which our losses greatly exceed this figure). Fox said this would be done \$3750.00 next day 28th and \$3250.00 by December 1st. I was unable to reach Fox on the 28th or 29th.

Guido was then contacted by Arnold and was told he was the primary contact for THA DOGG POUND and did not hear about these shows. Guido told him that he would send over the contract signed by Bing Worthington along with the copy of the deposit check. After doing this Arnold gave Bings direct contact number to Guido to call. Guido called right away got ahold of Bing he said he did not sign the contract and it was false. During this time Arnold had contacted and said over the phone to Guido it really looked like Bing signed it.

On November 30th I got a text from Fox asking me for my bank account information so he could deposit \$3750.00 immediately and \$3250.00 next day. This did not happen December 2nd Fox text me after numerous calls to him Fox said in text I'm waiting for funds to clear his account so he could make deposit to my account. This went on every day after same thing last text I received was on December 5th Text "I'm waiting for funds to clear the bank is going to call me when funds clear" After December 5th I've placed many calls and text to Fox and have had no response since.

Guido was contacted by Bing on the night of Dec 2 asking on how he could make it right since Fox was a good friend of his and were working partners. During the phone call Bing kept stating that he did not sign the contract but was willing to help fix the problem since Fox and him were partners. Guido stated his plans on filing charges and going to court would be the next step for E Concert Live and Gweedo Productions. In this matter. On Dec 5th text messages were sent out stating to Arnold and Bing that the money was not returned, Arnold replied saying he thought this would happen and that Guido should take it to the next

step.No reply from Bing after Dec 2.

We were expecting sold out shows for both dates the capacity of the venues and tiket prices are Clubhouse cap 600 \$20 presale & \$25 door and DV8 Night Club 1200 cap \$18 presale and \$22 door which brings our total gross potential Total between \$33,600.00 - \$41,000.00.
